Proposed Spring 2025 Schedule Changes

Why is WRTA Recommending Schedule Changes?

- One of the main passenger complaints to the WRTA and Customer Service is that buses are running late, and are not on time.
- On average, WRTA buses were 61% on-time between July 2023 and June 2024.
- WRTA has heard from its riders; from the 2024 Customer Satisfaction Survey, 'buses arriving on-time' received the lowest scoring satisfaction rating – 2.7 out of 4
- Changes in the schedules account for possible increases in traffic, population, and ridership.



WRTA Schedule Analysis

- WRTA began working with a transit consulting agency and scheduling subject matter expert (CSched) in late 2023
- The consultant performed a technical review of all fixed-route schedules with a goal to improve on-time performance and overall system reliability
- Working towards 'clock-face' scheduling for most routes, while being cognizant of 8 bus slips at Hub, and bus bunching issues on certain corridors
- WRTA goal: improve fixed route on-time performance to 80% for all routes, with a 95% on-time departure from the Hub



WRTA Schedule Analysis Methodology

- One year's worth of "raw" vehicle data was analyzed to perform a comprehensive review of WRTA bus operations.
- Used WRTA data to re-calibrate route schedules for efficiency, while ensuring proper rest and recovery time for operators
- Weekday, Saturday, and Sunday schedules have been crafted with the constraints of no additional vehicles, or increase in the operating budget
- The schedule analysis found that in order to increase reliability on certain routes, there would need to be a reduction in trips. However, other routes had schedule time available to add in more trips.



Public Outreach Process and Schedule

- The WRTA created a website (therta.com/schedule-changes) to see each of the proposed new route schedules.
 - The proposed schedule changes are not final until voted on by the WRTA Advisory Board at their February 20, 2025 meeting.
- Host public meetings (virtual, in-person), and information sessions at the Hub for public to review and provide feedback (details at the end).
- Administration to present public review findings at the February WRTA Advisory Board meeting
 - WRTA Advisory Board votes to endorse, or modify recommendations
- New schedules could go into effect as early as the end of April 2025.
